The good news for 2011 is that despite facing shrinking resources and budget cuts, Anu Family Services has continued to make outstanding progress on our goals and our mission by finding new ways to bring leadership and innovation to our field.

***Anu's rates of children discharged from treatment foster care to permanent families in the last quarter skyrocketed to an all-time high of 84%, while our lengths of stay in out-of-home care continue to drop to record lows.***

In an increasingly hostile and under-resourced funding environment, we are very proud of the progress we continue to make in connecting children to permanent homes. With your help, Anu is producing nationally-leading permanence outcomes in creating permanence and stability for traumatized children living in out-of-home care.

That's why in 2011 we expanded our operation beyond Wisconsin into Minnesota, and we are preparing now to offer treatment foster care as well as other innovative services such as Intensive Permanency Services through partnerships with innovative public partners who understand how essential networks of supportive connections and opportunities to heal wounds of multiple traumas and grief and loss are in the lives of children. Building our values of healing grief and building connections to create permanence, these new services are youth-driven and help to establish even more lifelong permanent connections for our kids, many of whom will find their forever family in the process.

This is our passion and our mission; this is why we are so appreciative of the ways you join us as a partner in creating permanency for our youth.

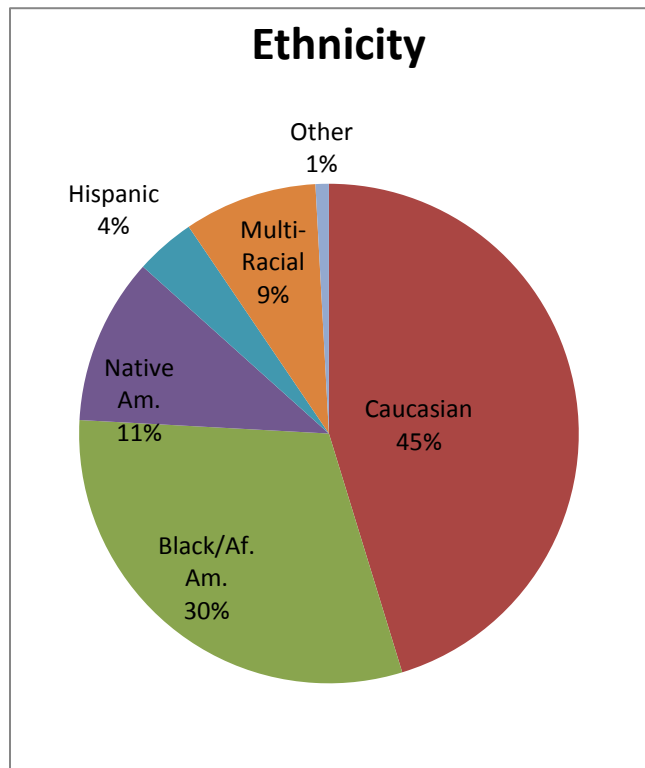
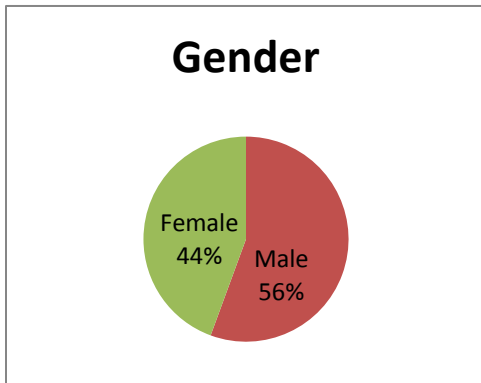
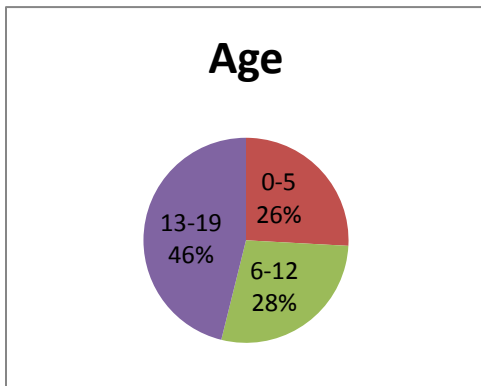
